The purpose of this public hearing is for renegotiating employment contract for the Superintendent of Schools, Steven Forte, for the school years July 2018 through June 30, 2023.

WHEREAS, the State of New Jersey has enacted P.L. 2007, C53, An Act Concerning School District Accountability; and

WHEREAS, Section 5 of the Act amended N.J.S.A. 18A:11-11 to require Denville Board of Education to provide public notice of the above action 30 days prior to the renegotiation, extension, amendment, or alteration of an employment contract with the superintendent of schools, assistant superintendent of schools, or school business administrator and

WHEREAS, Said 30 days advance public notice was provided to the public via posting in the office of the board secretary at 1 St. Mary's Place, 2<sup>nd</sup> Floor., Denville, NJ on June 22, 2018 and on the district's public website on June 22, 2018; mailing on June 22, 2018 to the district's official newspaper, Daily Record, and filing on June 22, 2018, with the clerk of Denville for public posting; and

WHEREAS, Section 5 of the Act amended N.J.S.A. 18A:11-11 to require Denville Board of Education to provide 10 days advance notice of a public hearing prior to the renegotiation, extension, amendment, or alteration of an employment contract with the superintendent of schools, assistant superintendent of schools, or school business administrator; and

WHEREAS, Said 10 day advance notice of the public hearing will be provided again to the public via posting in the office of the Board Secretary located at 1 St. Mary's Place, 2<sup>nd</sup> Floor, Denville, NJ on August 10, 2018 and on the district's public website on August 10, 2018; mailing on August 10, 2018 to the District's official newspaper, The Daily Record for publication, and filing on August 10, 2018 with the clerk of Denville for public posting, now therefore be it

RESOLVED, that the Denville Board of Education/trustees hereby designate 7:00 p.m. at Township of Denville, Council Chambers, Denville on August 20, 2018 as the public hearing required by the Act.

Members of the public are invited to submit public comments regarding the renegotiation of the Superintendent's employment agreement. The Board, pursuant to N.J.S.A. 10:4-12 (b), the Open Public Meetings Act, shall not publicly discuss personnel matters and shall not respond to comments made by members of the public; however, the board will give all comments appropriate consideration.

Please be aware that the subject of this hearing retains the right of privacy and shall retain all rights regarding defamation and slander according to the laws of New Jersey. The board shall not be held liable for comments made by members of the public.
